

Chesapeake City Jail Expansion Chesapeake, VA

Moseley Architects provided an action plan, and an amended planning study that considered alternative solutions for the detainee population in the city jail. The action plan provided an assessment of existing facilities and prepared a life cycle cost analyses for four alternatives to renovating or replacing aging facilities. The city considered the alternatives and selected the recommended phased approach.

Subsequently, Moseley Architects amended a Community Based Corrections Plan Planning Study that had been previously prepared by another consultant. Upon approval of commonwealth reimbursement, Moseley Architects prepared bid documents and administered construction for the first phase of the expansion, which included 192 dormitory beds; eight restrictive housing cells; spaces for administration, medical services, and training; as well as a warm-up kitchen, laundry room, and barber shop.

Henry County Jail Martinsville, VA

The former Henry County Jail was one of the most overcrowded detention facilities in Virginia. Moseley Architects partnered with the county on the preparation and submission of a Community Based Corrections Plan Needs Assessment and Planning Study in accordance with the State Board of Local and Regional Jails' *Standards for Planning, Design, Construction, and Reimbursement of Local Correctional Facilities*, and subsequent design services for the new 400-bed facility.

This includes a public lobby with video visitation, administration spaces with a training room, food service spaces, a laundry area, booking and intake, a warehouse with a loading dock, and a vehicular sally port.

This facility is one of the few in Virginia with a dedicated mental health wing. The wing features medical administration offices, high-density records storage, a laboratory, and a pharmacy. Exam rooms, including emergency treatment and mental health evaluation spaces, are also included. Infrastructure for general health services accommodates a dental operatory and X-ray room. Residents with contagious illnesses are separated from the rest of the population through negative pressure holding and shower areas.



City of Virginia Beach Jail Security Upgrades Virginia Beach, VA

This project upgraded the electronic security system that serves three buildings (built in 1976, 1992, and 2005), which house an average daily population of 1,427. The new system provides non-proprietary integrated IP-based control, including door control and emergency release; two-way digital intercoms and paging; cameras and video recording; card access with badging and reporting; and utility controls such as lights, water, TV, receptacle, and inmate phones.

Additional features include 22 new touch screen computers that control the system, including six new ergonomic sit-stand workstations in master control. In addition, new IP cameras (located considering PREA); digital intercoms and paging stations; HID card readers; RFID system for inmate, staff, and visitor tracking; head-end equipment; UPSs; PLCs; digital amplifiers; and data converters and fiber connections between the three buildings and courts.

Hampton Roads Regional Jail Renovations

Portsmouth, VA

Moseley Architects is providing on-call architectural and engineering services at the Hampton Roads Regional Jail for three projects. The first project consisted of replacing the entire kitchen floor while maintaining operation of the kitchen through construction. This was accomplished by creating a detailed phasing plan during design with facility staff, which included the use of a temporary hood, as well as utilizing the adjacent staff dining room for the serving lines.

The second project will provide a full roof replacement. The existing roof will be removed down to the roof structure. A new fully adhered polyvinyl chloride (PVC) membrane roof will be provided, along with new insulation, to meet the energy code.

Lastly, we are providing renovations to the stormwater management system to eliminate flooding. The project originated with a study of the existing stormwater structures and ponds to determine the needs and most cost effective manner to resolve the flooding issues. Ultimately, the two stormwater ponds in the front of the building will be remediated with the construction of new outfall structures constructed.

Prior to these projects, Moseley Architects provided security engineering design services for the facility's security control system upgrade, which is one of the first and largest security system upgrade planning studies that was approved for reimbursement by the Virginia Department of Corrections and Local and Regional Jails.

Pittsylvania County Jail CBCP Needs Assessment and Planning Study Chatham, VA

In 2018, Moseley Architects prepared a comprehensive justice needs assessment of Pittsylvania County's jail to assist the county in planning for the design and construction of a new or renovated facility. The study identified the amount of additional space needed; provided information to eliminate current space deficiencies; anticipated growth through a 20-year planning horizon; and developed the preliminary information necessary to assist with capital project budget planning.

We are currently providing an updated Community Based Corrections Plan Needs Assessment and Planning Study, which will be submitted to the Virginia Board of Local and Regional Jails in 2023. The assessment identified that a new replacement detention facility is needed. The rated capacity of the current facility is 36, while the assessment has identified the need for 146 beds.

The primary elements of the needs assessment consist of:

- a description of the jail system, facilities, and programs in the detention center's service area;
- a description of current offender population and existing criminal justice trends;
- a long-term forecast of jail bed needs for male and female offenders;
- preparation of options for addressing any bed need shortfalls; and
- preparation of a written report.

The planning study consists of:

- a statement of the project regarding compliance with jail standards;
- a statement of the planned general population design capacity of the proposed facility as determined and approved in the needs assessment;
- a statement of rated capacity of the existing facility;
- changes to operating program (procedures);
- facility planning program expressed on existing conditions plans;
- site data;
- a statement of management concept;
- a written description of the project;
- an assessment of the condition of the jail;
- conceptual floor plans, building elevations, site plan, and building sections;
- an energy analysis;
- an analysis of staffing needs and six-year operating budget cost;
- a budget estimate;
- schedule for implementation; and
- a listing of sources of allocated and projected construction or capital funds involved in the project.

Maintaining On-going Operations

Maintaining operations at your existing facility will be critical to your administrators and staff throughout construction. One of the most significant challenges related to renovation and expansion projects in occupied facilities is successfully constructing them while minimizing disruption to on-going operations. Maintaining the safety and security of staff, inmates, and visitors will be our highest priority.

We will develop phasing plans for each alternative based on established priorities. During the development of the preferred conceptual design, we will consider the impact of construction phasing to:

- minimize impact on staff, residents, and visitors;
- test the conceptual plan to determine that an acceptable phasing schedule can emerge from the preferred alternative, which does not negatively impact critical facility activities and minimizes impact on construction costs:
- consider how service utilities may drive the phasing schedule so that existing services can be back-fed and new services are not in areas out of phase;
- determine the most logical sequence of each phase to avoid disrupting construction with unreasonable or costly changes to plans; and
- quantify any extended schedule impact on construction costs and budget.

Understanding of Potential Issues, Opportunities, and Constraints



Moseley Architects partnered with the ACRJ from March to December 2021 on a Community Based Corrections Plan Needs Assessment and Planning Study and subsequent engagement with the Board of Local and Regional Jails for approval of reimbursement of eligible project expenses in support of the proposed renovation and expansion to your regional jail. Reimbursement approval totaled \$11,689,250. During this time, we have met extensively with ACRJ officials, Authority Board members, and Virginia Board of Regional Jails' staff and are thoroughly familiar with the deficiencies of your existing facility.

The goals of the proposed improvements included providing increased safety and security for detainees and staff, striving to meet the current Board of Regional Jails' *Standards for the Planning Design, Construction and Reimbursement for Local Correction Facilities*, while providing a facility based on trauma-informed design principles.

We were also tasked with addressing the following:

- primarily renovating the old section of the facility;
- providing equitable housing for women;
- improving air quality;
- creating outdoor recreation areas;
- replacing outdated and inefficient major mechanical systems
- improving air filtration in preparation for future pandemic and other widespread health issues;
- improving correctional officer safety and efficiency;

ABOVE During our Community Based Corrections Plan Needs Assessment and Planning Study for the ACRJ, we provided an initial design option for your renovated and expanded facility.

- improving the staff environment;
- increasing programming space;
- increasing the number of showers and toilets in housing units;
- replacing current floor coverings in all areas;
- creating a dedicated mental health unit;
- and improving and enhancing restricted housing

Our report presented the following information, which is required in a Community Based Corrections Plan:

- a brief introduction to the study, a summary of findings, and a description of the organization of the report;
- an analysis of the confined inmate population and inmate population trends;
- a description of the criminal justice system serving the regional service area with information concerning crime and arrest trends;
- a summary of the physical layout of the existing jail;
- an overview of community-based programs intended to provide options to incarceration; and
- a population projection methodology and inmate population forecast through 2035.

The study recommended a partial demolition, expansion, and renovation that would meet the Virginia



Board of Corrections standards. The project would not increase capacity, as the projected inmate population is not anticipated to grow through 2035 due to local programs and alternatives to incarceration. This is due to local programs and alternatives to incarceration. Our proposed renovation and expansion would consist of demolishing the east wing of the original 1975 portion of the jail, including its rated capacity of 65 beds, and constructing three general population housing units to replace those beds. A special purpose housing unit and a mental health housing unit near the existing medical unit would be provided, as well as a dedicated family visitation area, attorney visitation area, and a special management area.

The project also includes renovating the remaining portion of the 1975 jail, which has not been renovated since it was originally constructed. The renovation would eliminate bar grates, upgrade plumbing fixtures, provide new windows and a new roof, integrate additional natural daylight, and provide a new mechanical system. In addition, existing spaces will be re-configured to accommodate more multi-purpose classroom space, additional secure administrative space, new security spaces, and the re-configuration of dayrooms.

Repurposed interior multi-purpose space and new outdoor recreation space are also proposed through our


study to provide enhanced support to detainees and meet jail standards.

While we understand our proposed solution and design will need to be updated to meet the community's expectations, we look forward to this tremendous opportunity to continue serving the Albemarle-Charlottesville Regional Jail on this renovation and expansion project.

ABILITY DELIVER SERVICES

The following project approach outlines key tasks, which can be refined in consultation with the ACRJ and your representative/project manager. We anticipate that your project will be developed in phases to provide opportunities for milestone approvals. A schedule of meetings with project stakeholders and quarterly presentations to the Regional Jail Board Authority, as well as the community, will be developed at the outset of the renovation and expansion to facilitate timely input, feedback, and approval throughout the planning and design process.

The most important aspect of successful jail facility design is understanding that there is no universal solution to your needs. Each jail facility is different, and it is vital to build the number and types of detention beds that you need for the Albemarle-Charlottesville Regional Jail. Failing to do this will sacrifice the safety



of the officers and staff who manage the facility and will also increase the cost.

Our approach is to provide the ACRJ with a safe, secure, operationally efficient, and well-constructed solution that will serve you for many years to come.

The following services are proposed. This project approach will be reviewed with ACRJ and customized to meet your expectations.

Project Organization

- Establish ACRJ and Moseley Architects project contacts and stakeholders, including Col. Kumer, others, Lt. Barnabei, Captain Thomas, and other ACRJ staff and Authority Board members, as well as your representative/project manager and other appropriate regulatory agencies.
- Discuss desired program for validation of intended use.
- Discuss and refine the project schedule and phasing issues.
- Discuss budget parameters and current construction market conditions.
- Receive relevant documentation from the ACRJ, including the latest completed study and updates.

- Review project approach and establish communication procedures between ACRJ and Moseley Architects.

- Determine sources of required data and information (ACRJ to assist in identifying sources and availability).
- Identify appropriate benchmark operational parameters.
- Coordinate stakeholder involvement and consensus-building processes.
- Determine the lock types, glazing, and other detention equipment needs to meet the ACRJ's expectations as well as the standards of desired use.
- Conduct community engagement activities with the Miles Agency.

Data Collection and Analysis

- Review site and the existing jail documentation and observe conditions on-site to include parking, storage, security, and privacy.
- Determine topo and boundary survey requirements with our civil engineer, Timmons Group.





- Confirm geotechnical and environmental evaluations with Timmons Group, as needed.
- Confirm the adequacy of existing water and sanitary sewer service to support the expanded facility and other site-related needs with Timmons Group.
- Document existing conditions.
- Field measure the facility as required.
- Assemble information on quantity, location, and physical condition of parking.
- Review infrastructure (HVAC, electrical, structural, etc., including capacities, physical condition, and any improvements made by the ACRJ).
- Confirm existing space allocations.

Evaluation of Alternatives

- Develop and review alternative facility concepts with the ACRJ and your representative/project manager.
- Document each alternative in graphic and written format.


- Conduct public presentations with the community and discussions as desired by the ACRJ.
- Assist the ACRJ in selecting and refining a preferred concept, finalize construction phasing and sequencing of the plan in accordance with needs and priorities.

Schematic Planning and Design

We will establish a schedule with meeting dates to review each aspect of the design. Security components and associated electronics will be discussed with IT personnel and, if requested, demonstrations of equipment will be arranged. Structural, plumbing, mechanical, and electrical issues will be discussed with the ACRJ's maintenance staff. We will maintain open and frequent communication, exploring options and solutions, as we did when assisting the ACRJ with your chiller in May

Budgeting, Cost Estimating, and Schedule

Completing a project on time and within budget requires more than the dedication of a few individuals. To be fully effective in meeting our clients' expectations for project delivery, we have built a resource of in-house professionals who offer depth in capabilities as well as in numbers.

Budget

Understanding and complying with your project budget will be essential. Moseley Architects will employ the following tools to monitor project cost:

- Initial Budget Review We will meet with ACRJ and your representative/project manager to review and gain a detailed understanding of your proposed budget and will assist in developing total project budget components as requested.
- Monitoring of Project Scope Team leaders will monitor the scope of your project on issues that may adversely affect budget compliance, including site conditions, regulatory requirements, construction market factors, and building user requests.
- Milestone Cost Estimates Milestone estimates serve as a primary means of monitoring estimated construction costs. We will use estimates as a basis to develop recommendations for revisions in design to maintain budget compliance. Any such revisions will be implemented only after consultation with the ACRI administration.

Schedule

An overall schedule will be finalized at the project's outset in consultation with the ACRJ and your representative/project manager. The schedule will address not only design and document production time, but will also include appropriate intervals for preparing milestone estimates, ACRJ review and approvals, and regulatory review. All stakeholders will have access to the schedule. Moseley Architects' team leaders will monitor the schedule and keep you apprised of issues that may impact it, and it will be updated as necessary.

A "micro-deadline" approach will be used to maintain the schedule for each project phase. This will facilitate schedule monitoring and compliance by the architectural and engineering team. The micro-deadline approach will break down each phase into individual tasks that are coordinated with agency requirements. A required completion date will be established for each task, rather than simply establishing an overall completion date for the phase. Compliance with micro-deadlines results in timely completion of the overall phase, and thus the overall project.

Additionally, Moseley Architects uses a series of checklists for project planning. We develop phase requirements and sustainability checklists for the design phase of each project as well as "spot-check" and Redi-Check checklists, which are completed by the project team after the design development and construction documents phases. The following chart summarizes our history of completing projects on schedule and within budget.
