Guidelines and Responsibilities for Work Release/HEI Inmate Transportation

The following Rules and Regulations are for persons who transport inmates currently participating in a Work Release/HEI Program in any capacity. These rules and regulations must be signed prior to any person being allowed to transport a Work Release/HEI inmate.

Printed name of Work Release/HEI inmate being transported

- 1. You must be at least 18 years old to transport Work Release/HEI participants.
- 2. I will transport the Work Release/HEI inmate to and from the job site using the most direct route possible.
- 3. I will not make any stops while transporting the Work Release/HEI inmate unless it is a valid emergency.
- 4. I will immediately notify Work Release staff of any unauthorized stops should I make any while transporting a Work Release/HEI inmate.
- 5. If I am unable to continue transporting the Work Release/HEI inmate, I will notify the Work Release Department immediately to arrange transportation for the inmate.
- **6.** Upon transporting the Work Release/HEI inmate to the designated job site, I will leave the premises immediately.
- 7. Inmates are not allowed to associate with inmates of the opposite sex; therefore they are not to be transported with inmates of the opposite sex under any circumstances.
- 8. I will provide a copy of my valid driver's license, vehicle registration, and auto insurance to the Work Release Department prior to transporting any Work Release/HEI inmates.
- 9. I will ensure that the vehicle I use to transport inmates is fully operational, in good standing in regard to its inspection, and is fueled.

| 13. | I understand that the visitor/transportation guidelines will be strictly enforced. Shorts, revealing tops, tank tops, halter-tops, and tube tops are not allowed in this facility. Individuals will be turned away if their attire is deemed inappropriate. | | |
